

# Agency 31 - Military Department

## Statutory Authority:

- 1) Section 14, Article IV and Article XIV, Constitution of Nebraska provides for the Militia, its personnel, organization and discipline.
- 2) R.R.S. 55-101 through 55-180 (Military Code) provides regulations for the control, equipment organization and command of the Nebraska National Guard.
- 3) R.R.S. 55-201 through 55-218 (State Guard) provides the regulation for the operation of the Nebraska State Guard.
- 4) R.R.S. 81-829 (Emergency Management Act) provides for disaster and emergency management operations.

## Vision Statement:

Coupled teams, intensively engaged at community, state, and national levels to better serve the entire state and nation with:

- Stable and relevant military missions
- Strong NEMA/community partnerships
- Aggressive pursuit of new opportunities

## Mission Statement:

Maintain the Nebraska National Guard (Army & Air) in a high state of readiness for missions and deployment in support of national security objectives and state emergencies with well trained personnel and ready equipment.

Maintain a State Disaster and Emergency Management program to reduce the vulnerability of the citizens and communities of the State in the event of a natural or man-made disaster or attack by coordinating the resources of Nebraska communities, State government and the Federal government in the areas of disaster preparedness, disaster response, disaster recovery and hazard mitigation.

## Agency 31 - Military Department Program 192 - Governor's Emergency Aid

### Program Objectives:

The Governor's Emergency Program is authorized under the provisions of R.R.S. 81-829.42 to care for the unusual and extraordinary burdens imposed on the state and its political subdivisions by disasters, emergencies, or civil defense emergencies. The primary purpose of the program is to assist in restoring the essential public services. The Governor's Emergency Program is intended to be supplemental to local response and recovery efforts and not the primary source of assistance. When approved by the Governor, assistance is administered by the Adjutant General/State Emergency Management Director acting for the Governor.

- To provide 25 hours of classroom contact time to over 900 elementary school children (5th grade) from the Lincoln community.
- To provide effective and efficient management of the Tuition Assistance Program (Program 548)
