## Program 011 - Attorney General's Salary

### Program Objectives:

Program 011 is the salary and benefits of the Attorney General, a position established by the Nebraska Constitution. The salary is set by statute by the Legislature. The Attorney General directs the Department of Justice, which is responsible for the general control and supervision of all legal actions and proceeding in which the state may be a party or be interested. The Attorney General has charge and control of all legal business of state departments which requires the services of attorney or counsel to protect the interests of the State. Pursuant to Neb. Rev. Stat. 84-201.01 (Cum.Supp. 1992) the annual salary of the Attorney General is sixty-four thousand five hundred dollars.

The Department of Justice is responsible for all legal business of state departments which requires legal services to protect the State's interests.
