

Agency 073 - STATE BOARD OF LANDSCAPE ARCHITECTS

STATUTORY AUTHORITY:

The State Board of Landscape Architects was established in 1967 to govern the practice of landscape architecture in the State of Nebraska through the Professional Landscape Architects Act. The latest revisions to the Act, Neb. Rev. Stat. §§ 81-8,184 to 81-8,208, became effective on July 19, 2012.

VISION:

The State Board of Landscape Architects is engaged as a leader in safeguarding the life, health, property and promoting the public welfare of the people of Nebraska as related to the use and protection of the natural and built environment affected by the practice of landscape architecture.

MISSION AND PRINCIPLES:

The State Board of Landscape Architects establishes requirements for education, experience, examination, and enforcement for the practice of landscape architecture in Nebraska and assures qualified individuals are licensed to safeguard the life, health, and public welfare in Nebraska.

The Board reviews the vision and mission statements annually.

GOALS:

The Board identified desired goals to be accomplished over the next two bienniums:

1. Provide quality services to applicants, licensees, and citizens of Nebraska
2. Increase public and industry awareness of statute established for practice of landscape architecture
3. Revise laws to strengthen licensure and enforcement standards for professional landscape architects in Nebraska
4. Continually review and update Board's strategic plan (the current plan is attached)
5. Offer online renewals for professional landscape architect licensees
