The NAC accomplishes this by supporting arts activities through grants and technical assistance for nonprofit arts organizations such as museums; symphonies; playhouses; community arts councils; nonprofit community and social service agencies that provide arts activities; public and private schools, colleges and universities; and artists, writers, and performers.
